EFF FS calls MEC and municipalities to exempt health facilities from loadshedding

The Economic Freedom Fighters in the Free State province has called MEC of Health in the province together with local municipalities to exempt health facilities from loadshedding. The party said it remains of the view that the value of all values should remain a human life as it is enriched in the constitution of the Republic of South Africa, and at all material times we should strive to protect human life.

“It has come to the attention of the party that majority of clinics and hospitals in the province continue to be affected by loadshedding. At times hospitals such as Hopstad, Boitumelo and others are found with malfunctioning power generators without diesel. This is happening against the backdrop of a parliamentary village which is exempted from loadshedding” said the party’s statement. The party further called the MEC of Health in the province Montseng Tsiu to investigate claims made in her presence by a staff member at Boitumelo Hospital and if found to be truthful heads must roll. “EFF will not rest until all lives of the Free State citizens are valued the same way sa those of the politicians”.
