Notice is hereby given in terms of **Section 17(3)(a)(ii) and 24(1)(2) of the Municipal Finance Management Act 2003 and section 14(1) and (2) of the Local Government: Municipal Property Rates Act 2004** that the Municipal Final Estimates of Revenue and Expenditure for the 2026/2027 financial year was approved in Council on 29 May 2026, of which a copy is available for inspection at the Office of the Chief Financial Officer during office hours of the Council
2. Notice is also hereby given that:
- I. The final general assessment rates for the financial year ending 30 June 2027 has been assessed in accordance with the provisions of section 24(2)(c) of the Act:

The aforementioned proposed rates are recoverable by the Council in terms of the provisions of the Act and payable in equal monthly instalments except for agricultural land and state property. **In terms of Section 24(2)(c) of the Act and section 64(2) of the Municipal Finance Management Act 2003**, interest is payable on all rates in arrears
4. **Final Tariff increase:**
- Water Tariffs = 12%
 - Waste Management = 3.4%
 - Waste Water Management = 3.4%,
 - Electricity = 9.01%
 - Sundry Tariffs = 3.4%
